The Police Jury of the Parish of Rapides, State of Louisiana, met in Regular Session at its regular meeting place, the Police Jury Room of the Parish Courthouse, 701 Murray Street, Alexandria, Louisiana, on Monday, June 23, 2016, at three (9:00) o'clock a.m. (Central Standard Time) pursuant to the provisions of a written notice given to each and every member thereof and duly posted in the manner required by law, viz:

NOTICE IS HEREBY GIVEN that the special meeting of the Police Jury of the Parish of Rapides, State of Louisiana, has been ordered and called and will be held at its regular meeting place, the Police Jury Room of the Parish Courthouse, Alexandria, Louisiana on Tuesday, June 23, 2016, at 9:00 a.m., for the following purposes to wit:

- 1. Motion to award construction contract for the Rapides Parish Coliseum Bathroom Finish Out, ADG Job No. 12014, to the low bidder, Ratcliff Construction, for bid amount of \$405,000 as recommended by Alliance Design Group, Project Architect, and concurred by Facility Planning and Control as well as authorize the President to sign all necessary documents.
- 2. Motion to adopt the following ordinance:
