REGULAR SESSION JANUARY 14, 2019

The Police Jury of the Parish of Rapides, State of Louisiana, met in Regular Session at its regular meeting place, the Police Jury Room of the Parish Courthouse, 701 Murray Street, Alexandria, Louisiana, on Monday, January 14, 2019, at three (3:00) o'clock p.m. (Central Standard Time).

did, in open and public session, examine the official certified tabulations of votes cast at the said election, and did examine and canvass the returns of the said election, there having been submitted at said election the following proposition, to wit:

PROPOSITION (MILLAGE CONTINUATION & REDEDICATION)

Shall Fire Protection District No. 10 of the Parish of Rapides, State of Louisiana (the "District"), be authorized to continue to levy the tax authorized at an election held on July 19, 2008 (the "Tax"), at a rate of twenty-nine and eleven hundredths (29.11) mills on all property subject to taxation within the District (an estimated \$118,000 reasonably expected at this time to be collected from the levy of the Tax for an entire year) for an additional ten (10) years, beginning with the year 2020 and ending with the year 2029, and shall the District be further authorized to rededicate the use of the proceeds of the Tax, heretofore or hereafter received, for the purpose of acquiring, constructing, improving, maintaining or operating fire protection and emergency medical service facilities, vehicles and equipment, including both movable and immovable property, and including paying the cost of obtaining water for fire protection purposes, said millage to represent a nine and eleven hundredths (9.11) mills increase (due to reassessment) over the 20 mills authorized to be levied through the year 2019 pursuant to the election held on July 19, 2008?

There was found be said count and canvass that there was a total of 102 votes cast IN FAVOR OF the Proposition and a total of 27 votes cast AGAINST the Proposition, as hereinabove set forth, and it was further found and determined that there was a majority of 75 votes cast IN FAVOR OF the Proposition as hereinabove set forth.

Therefore, the Governing Authority did declare and proclaim and does hereby declare and proclaim in open and public session that the Proposition as hereinabove set forth was duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the said special election held in the District on Saturday, December 8, 2018.

Pursuant to the provisions of a resolution adopted by the Police Jury of the Parish of Rapides, State of Louisiana (the "Governing Authority"), acting as the governing authority of Fire Protection District No. 10 of the Parish of Rapides, State of Louisiana (the "District"), on August 13, 2018, NOTICE IS HEREBY GIVEN that a special election will be held within the District on **SATURDAY**, **DECEMBER 8, 2018**, and that at the said election there will be submitted to all registered voters in the District qualified and entitled to vote at the said election under the Constitution and Laws of the State of Louisiana and the Constitution of the United States, the following proposition, to-wit:

PROPOSITION (MILLAGE CONTINUATION & REDEDICATION)

Shall Fire Protection District No. 10 of the Parish of Rapides, State of Louisiana (the "District"), be authorized to continue to levy the tax authorized at an election held on July 19, 2008 (the "Tax"), at a rate of twenty-nine and eleven hundredths (29.11) mills on all property subject to taxation within the District (an estimated \$118,000 reasonably expected at this time to be collected from the levy of the Tax for an entire year) for an additional ten (10) years, beginning with the year 2020 and ending with the year 2029, and shall the District be further authorized to rededicate the use of the proceeds of the Tax, heretofore or hereafter received, for the purpose of acquiring, constructing, improving, maintaining or operating fire protection and emergency medical service facilities, vehicles and equipment, including both movable and immovable property, and including paying the cost of obtaining water for fire protection purposes, said millage to represent a nine and eleven hundredths (9.11) mills increase (due to reassessment) over the 20 mills authorized to be levied through the year 2019 pursuant to the election held on July 19, 2008?

The said special election shall be held at the polling places for the following precincts, which polls will open at seven o'clock (7:00) a.m. and close at eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541, to wit:

PRECINCTS S27 (IN PART) S28 (IN PART) S29

The polling places at the precincts set forth above are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, shall be those persons designated according to law.
