CALL TO ORDER

Chairperson, Sonia Chevallier called the meeting of the Rapides Parish Workforce Development Board to order.

GUEST SPEAKER

coolplanet

Mr. Michael Bukowski, Business Unit Leader for Cool Planet, shared with the board that due to the oil price drop the building at the port in Alexandria has been put on hold. When plant is complete they will produce a bio carbon called Cool Terra. This product is a type of soil amendment which will hold more water making the roots of plants grow more roots thus producing higher yields. Farmers will see a 17 to 1 rate on return. Other areas are producing 26% more tomatoes using Cool Terra. The first Alexandria plant will be a stand-a-lone bio-carbon plant



which will employ 10 -12 people. Future plans are to build an extension fuel and bio-carbon plant that will employ a total of 26.

AGENDA ITEMS

1. APPROVAL OF MINUTES

It was requested that the Workforce Development Board review and approve the minutes from the February 18, 2016 meeting.

On motion by Rich Dupree, seconded by Joan Lee with -0- nays, -0- abstained and 19 yes votes, the minutes from February 18, 2016 were approved.

1. Revised Policies for WIOA

Policy Number 400-01 and 400-02 - LWC recommended the Workforce Development Board have a policy for funding out-of-parish jobseekers. After research on best practices, we settled on no more than 25% of the participants enrolled in OJT or scholarship training could reside outside Rapides Parish.

Policy Number 400-03 – This is a clarification that resulted from LWC Monitoring Training. LWC identified that supportive services must be accompanied by a justification.

Policy Number 400-05 – Priority of Service – Modified policy to add that 51% of the participants must meet the criteria from the Priority of Service policy.

Policy Number 500-02 – Youth Eligibility – Modified policy to add that funding is to be for youth who are residents of Rapides Parish. However, Manager(s) may grant a funding request if youth's resident parish has no youth funds.

Policy Number 800-01 – Fiscal – Modified policy to determine if a cost is allowable prior to charging WIOA for that cost.

On motion by Chad Bynog, seconded by Christine McGraw, with -0- nays, -0- abstained and 19 yes votes, the Workforce Development Board approved the policy revisions.

1. Summer Youth Program 2016

The Summer Youth Employment Program (SYEP) will begin in May. The Youth Empowerment Services (YES) year round program is a structured program that offers employment and job skills. Youth are selected who meet age, residency, and income requirements and are placed with private or public employers for six weeks during the summer.
