GUEST SPEAKER:



Rose Killion, Senior HR Specialist at Boise Cascade, gave an update on the company. Boise Cascade is a fortune 500 company with 7000 associates across the United States and Canada, and operate two primary divisions, wood products and building material distribution centers. Wood products are in everyone's home, and Boise Cascade offers a wide range of building material products. Boise Cascade earns 7.9 billion in annual revenue and capitalizes on manufacturing and distribution, for both consumer and commercial construction. Boise Cascade has 38 wholesale distribution centers, 9 millwork shops, and 19 wood product plants across the United States and Canada. Boise Cascade promotes workforce readiness by partnering with many not-for-profit organizations and educational programs to develop and nurture future leaders. One such partner is Go-Fame, and together they sponsor, train, and pay individuals to attend AMT programs. Boise Cascade additionally sponsors local job fairs and partners with local schools to offer resume and job skills workshops.

While participants attended the job fair, DCFS was able to complete background screens and preliminary interviews, resulting in **88** contingent offers.
