Workforce Innovation and Opportunity Act (WIOA) Sec. 121(d)(2)(A) which states “an entity shall be designated or certified as a one-stop operator through a competitive process;” and further defined in 20 CFR 678.605. the Rapides Workforce Development Board is to follow local/state procure policies, and/or Uniform Guidance at 2 CFR 200.318 – 200.326 to procure a One-Stop Operator for the Rapides One-Stop Center. The selected contractor must be in place no later than July 1, in the amount of \$24,000.00, to begin July 1, 2025, and end on June 30, 2026, with option to renew for three (3) years and have the treasure amend budget accordingly. The funding for this contract will come from WIOA grant funds.
