The Police Jury of the Parish of Rapides, State of Louisiana, met in Special Session at its regular meeting place, the Police Jury Room of the Parish Courthouse, 701 Murray Street, Ste. 201, Alexandria, Louisiana, on Monday, June 29, 2020, at 3:00 p.m. (Central Standard Time), pursuant to the provisions of a written notice given to each and every member thereof and duly posted in the manner required by law, viz:

The Pledge of Allegiance was led by Mr. David Johnson

The Police Jury of the Parish of Rapides, State of Louisiana, was duly convened as the governing authority of said Parish by Hon. Craig Smith, President, who welcomed all present and then stated that the Police Jury was ready for the transaction of business.

The President asked if there was any public comment on any agenda item, to which there was no response.

On motion by Mr. Sean McGlothlin, seconded by Mr. Rusty Wilder, to appoint Ms. Theresa Pacholik as Parish Treasurer for the Rapides Parish Police Jury and set her salary at \$75,000 per year, effective July 1, 2020.

Substitute motion by Mr. Ollie Overton, seconded by Mr. Joe Bishop, to appoint Ms. Theresa Pacholik as Interim Treasurer for three (3) months pending advertisement for hiring a Treasurer.

On roll call vote the substitute motion failed 4-5.

Roll call vote for the original motion was as follows:

Nays: Scott Perry, Jr.

Mr. Scott Perry, Jr., who phoned in due to the COVID-19 pandemic, had assumed the Jury was voting on the substitute motion again. He stated he wanted his vote changed to yea.

On roll call vote the original motion carried 9-0.

On motion by Mr. David Johnson, seconded by Mr. Rusty Wilder, there being no further business, the meeting was adjourned at 3:31 p.m.
